1 Overview

Ball and Paddle is a simple 2D game featuring balls, blocks, a paddle, and powerups. The field has walls on the top, left, and right, but not on the bottom. You control a paddle at the bottom of the screen in order to keep the balls from dropping off the bottom of the field and aim the balls to destroy all the blocks on the level.

2 Basic Gameplay

You start with a number of remaining balls.

When the level starts, one ball will be on the screen. It will fall in a random direction and you will have to move the paddle to keep it from falling off the bottom of the screen. As you play, the ball will hit blocks. Some blocks can be destroyed by one hit while others take more. When all blocks that can be destroyed are gone, you will move to the next level.

If all balls on the screen fall off the bottom then you will lose one of your remaining balls and the level will reset.

During the level, a meter at the bottom of the screen will be slowly depleting. This is a bonus for finishing the level quickly. When you finish a level, you get the points for how much is left in the bonus meter.

3 Controls

These controls work for keyboard and mouse.

Left Move the paddle left.

Right Move the paddle right.

Spacebar / Mouse-click

Special Action, like shoot lasers if you have laser or releasing balls if you have glue.

4 Blocks

There are normal blocks, which can be destroyed by one hit, reinforced blocks which require two hits, and super reinforced blocks which require three hits.

There are invincible blocks which cannot be destroyed. These are not required to be destroyed for the level to end since they cannot be destroyed.

There are blocks that eat balls. These blocks look like holes. They can be destroyed by lasers or other balls if you have more than one. They are not required to be destroyed for the level to end since destroying them requires random powerups or losing extra balls.

5 Powerups

<i>Expand</i>	This powerup makes your paddle grow. It is represented by two arrows pointing outward.
<i>Shrink</i>	This powerup makes your paddle shrink. It is represented by two arrows pointing inward.
<i>Divide</i>	This powerup makes each ball into 3 new balls. It is represented by 3 balls.
<i>Laser</i>	This powerup gives you a laser on the paddle. Press space or click to shoot. It is represented by a paddle with lasers coming from it.
<i>Glue</i>	This powerup makes your paddle into glue, making balls stick to it. When they stick, press space or click to release the balls. It is represented by a letter G.
<i>Powerball</i>	This powerup turns your balls into “Powerballs,” which mean that your balls can go right through normal blocks instead of bouncing off of them. It is represented by a yellow ball, the color of the powerballs.
<i>Reverse</i>	This powerup makes the controls reversed. Left is right and right is left. This will change back if you get another reverse or if the level resets. It is represented by a letter R.
<i>Fast</i>	This powerup makes the balls move faster. It is represented by a letter F.
<i>Slow</i>	This powerup makes the balls move slower. It is represented by a letter S.

0. PREAMBLE

The purpose of this License is to make a manual, textbook, or other functional and useful document *free* in the sense of freedom: to assure everyone the effective freedom to copy and redistribute it, with or without modifying it, either commercially or non-commercially. Secondly, this License preserves for the author and publisher a way to get credit for their work, while not being considered responsible for modifications made by others.

This License is a kind of “copyleft”, which means that derivative works of the document must themselves be free in the same sense. It complements the GNU General Public License, which is a copyleft license designed for free software.

We have designed this License in order to use it for manuals for free software, because free software needs free documentation: a free program should come with manuals providing the same freedoms that the software does. But this License is not limited to software manuals; it can be used for any textual work, regardless of subject matter or whether it is published as a printed book. We recommend this License principally for works whose purpose is instruction or reference.

1. APPLICABILITY AND DEFINITIONS

This License applies to any manual or other work, in any medium, that contains a notice placed by the copyright holder saying it can be distributed under the terms of this License. Such a notice grants a world-wide, royalty-free license, unlimited in duration, to use that work under the conditions stated herein. The “Document”, below, refers to any such manual or work. Any member of the public is a licensee, and is addressed as “you”. You accept the license if you copy, modify or distribute the work in a way requiring permission under copyright law.
